INTRODUCTION: Howard County Library System (HCLS) is seeking proposals from qualified furniture reupholsters to provide reupholstering services for seating at the Savage Branch. This document is a Request for Proposal (RFP) for the services described below and does not obligate HCLS to accept responses from eligible Contractors. The RFP establishes minimum requirements a bidder must meet to be eligible for consideration and information included in the Contractor's bid response.

The selection of the successful Contractor will be made based on HCLS' evaluation and determination of the relative ability of each Bidder to deliver quality service in a cost-effective manner.

The following specific criteria will be evaluated and must be addressed in the proposal:

1. Company and Services Provided, Years in Business
2. Cost Proposal (Reupholstering, Fabric and Pick Up/Delivery)
3. Timeframe for completion, including pickup and delivery timeframe
4. References /Client List

HCLS is not obligated to accept the lowest bid and reserves the right to reject all bids or amend the project's scope. All Bidders must be duly licensed or otherwise able to perform work in accordance with all governing local authorities and to their satisfaction.

SELECTION: Vendors will be selected based on references, delivery timeframe, and cost.

- Padding and all other assembly components as needed.
- All nicks and marks on wood or aluminum to be buffed/repared as appropriate.
- Ensure all items are returned completed with quality workmanship and provide a one-year warranty on workmanship.
- Pick up and delivery of each item.
- See seating to be recovered beginning on page 3.

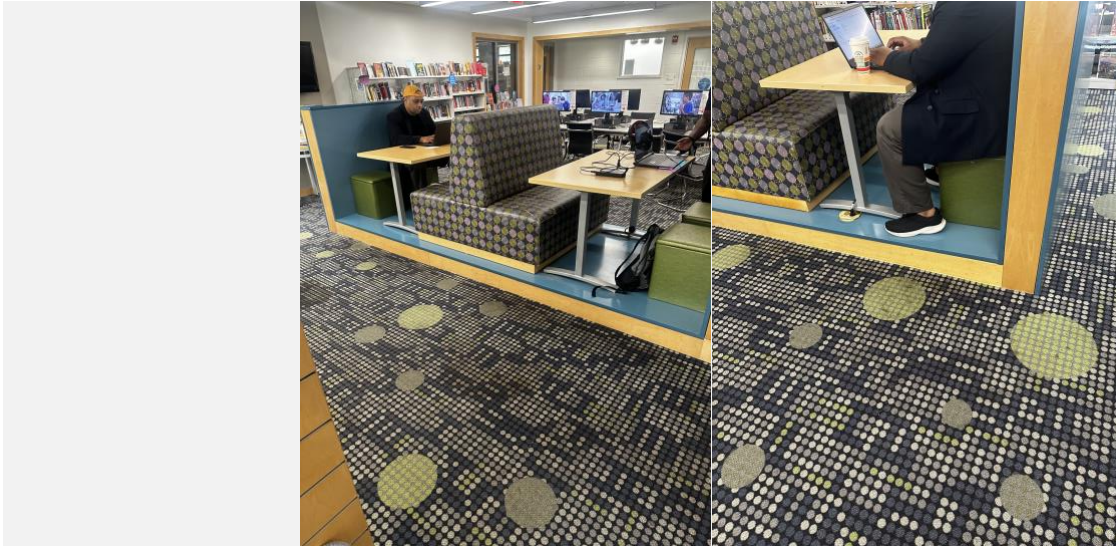
INSTRUCTIONS TO BIDDERS: Bidder is to format their response to include:
